1. 1. The Applicant will pay the Installation Charge, Construction Charge, or Service Connection Charge, if applicable, on signing this Application for Telephone Service.
2. 2. The Applicant will, when telephone service becomes available, take from the Association all telephone service to be used on the Premises described above and will pay therefore monthly rates to be determined from time to time by the Association, and approved by the Public Utilities Commission of Colorado.
3. 3. The Applicant does hereby grant to the Association, without cost, a right-of-way and easement to construct, operate and maintain a telephone line or system on the premises described above hereof and in or upon all streets, roads or highways abutting said premises.
4. 4. The Applicant will comply with and be bound by the tariffs of the Association, as amended from time to time and as approved by the Colorado Public Utilities Commission, and such lawful rules and regulations as may from time to time be adopted by the Association.
5. 5. Upon acceptance of this Application by the Association, this Application shall become and constitute an agreement between the Applicant and the Association, and shall continue in force for 30 days from the date service is made available by the Association to the Applicant, and thereafter until service is permanently discontinued by either party.
6. 6. All local service bills shall be paid in advance.
7. 7. All bills for local, toll or miscellaneous services are due when rendered and payable at the office of the Cooperative or agent.
8. 8. Payments not received on or before 11:00 a.m. the 23rd day of the month will be disconnected for non-payment and subject to a \$20.00 reconnection fee.
